#### **MINUTES:**

### **SOLICITOR'S REPORT:**

- a) Free Will/Brewery Waste Pre-Treatment –The Solicitor stated there was discussion on this topic during the PWTA section of this meeting so no further comment.
- b) Hidden Meadows Dedication and Easement The Solicitor stated he was still working on the Dedication and Easement.
- c) T-Mobile The Solicitor stated that he continues to work with T-Mobile and Rich Skilton (Southern Corrosion) regarding the lease and request to put additional equipment on the tank.

Upon motion by Bedillion, seconded by Algeo, the Solicitor's Report was unanimously approved.

#### **ENGINEER'S REPORT:**

- a) Pressure Reducing Vaults—The Engineer stated that the valves in the vaults have all been calibrated and tested. He further stated that the contractor was expected to return in the next couple of weeks to modify the grading.
- b) Booster Station The Engineer stated that the pumps have been successfully tested and were anticipating a full-blown start-up once the SCADA system upgrades were complete.
- c) Perkasie Green (Cedar Ridge) The Engineer stated the contractor was close to completing his work for Dedication to PRA.
- **d)** Hidden Meadows (Phase 3) The Engineer stated this was just about complete and ready for Dedication.
- e) Ridge Road Sewers The Engineer stated he received the PennDOT road opening permit. In addition, the Engineer recommended that the Board issue a Notice of Intent to Award, and following the receipt of a Certificate of Insurance and properly executed Bonds, to issue a Notice of Award.

#### **MANAGER'S REPORT:**

a) Well #11 Update – The Manager stated that Perkasie Borough Electric upgraded the electric at PRA's request. He further stated that the contractor had informed PRA that he would be installing the new pump sometime in mid-April as well, so the only thing PRA was waiting on would be the VFD. The Manager stated he was hopeful that they would have the VFD in a few weeks and once that was wired, they should be able to start up the pump. He further stated that PRA would be contacting the DEP once everything was ready to see if there was anything special that PRA would need to do prior to placing the well back in service. In addition, he stated that they anticipate that PRA will need to do all of the normal start-up samples.

- b) Ridge Road Sewer Extension to Mountain View Drive (Phase 1) The Manager stated he has scheduled meeting with all of the property owners on April 19, 2021 at 7:00 pm. He further stated that the PRA Board had approved a five (5) installment (4 year) payment plan for any property owner that connects by December 31, 2021.
- c) Manhole Lining The Manager stated that the manhole lining was completed on Walnut Street and Stony Crest Drive down to Constitution Avenue.

Upon motion by Horn, seconded by Bedillion, the Manager's Report was unanimously approved.

Upon motion by Watt, seconded by Algeo, the Board unanimously approved to credit 218 Parkridge Drive, account #2537, the sewer charges for a broken toilet that was since fixed in the amount of \$221.85.
